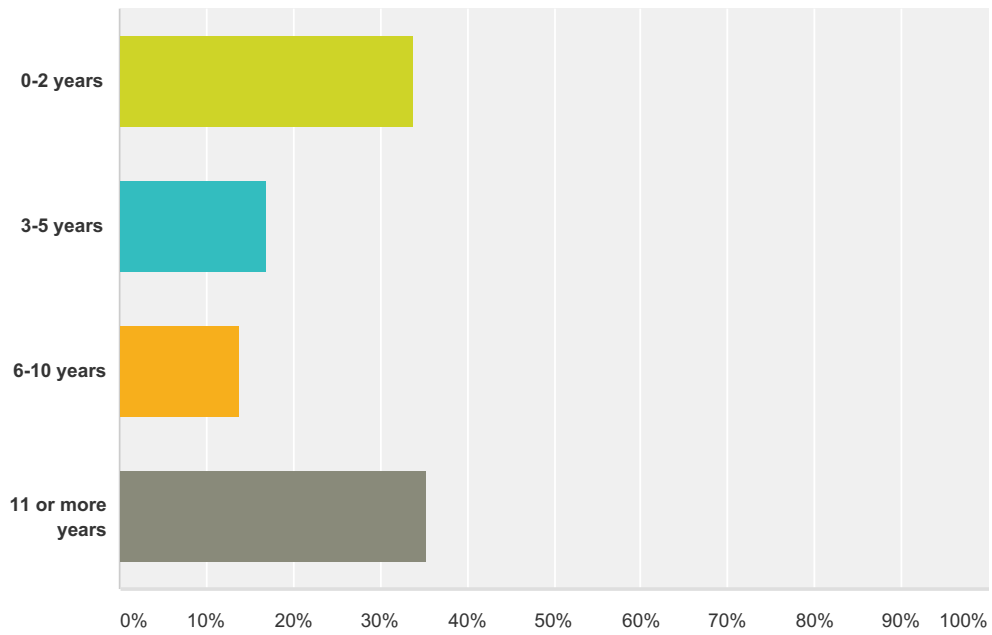


### Q1 How long have you been a member of the UABA?

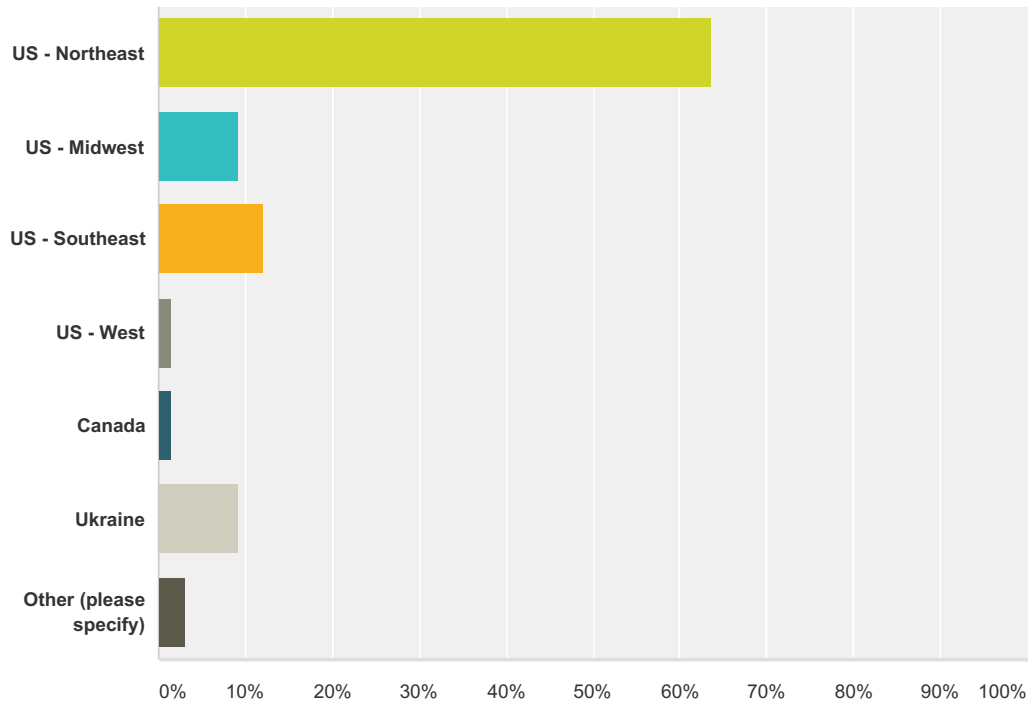

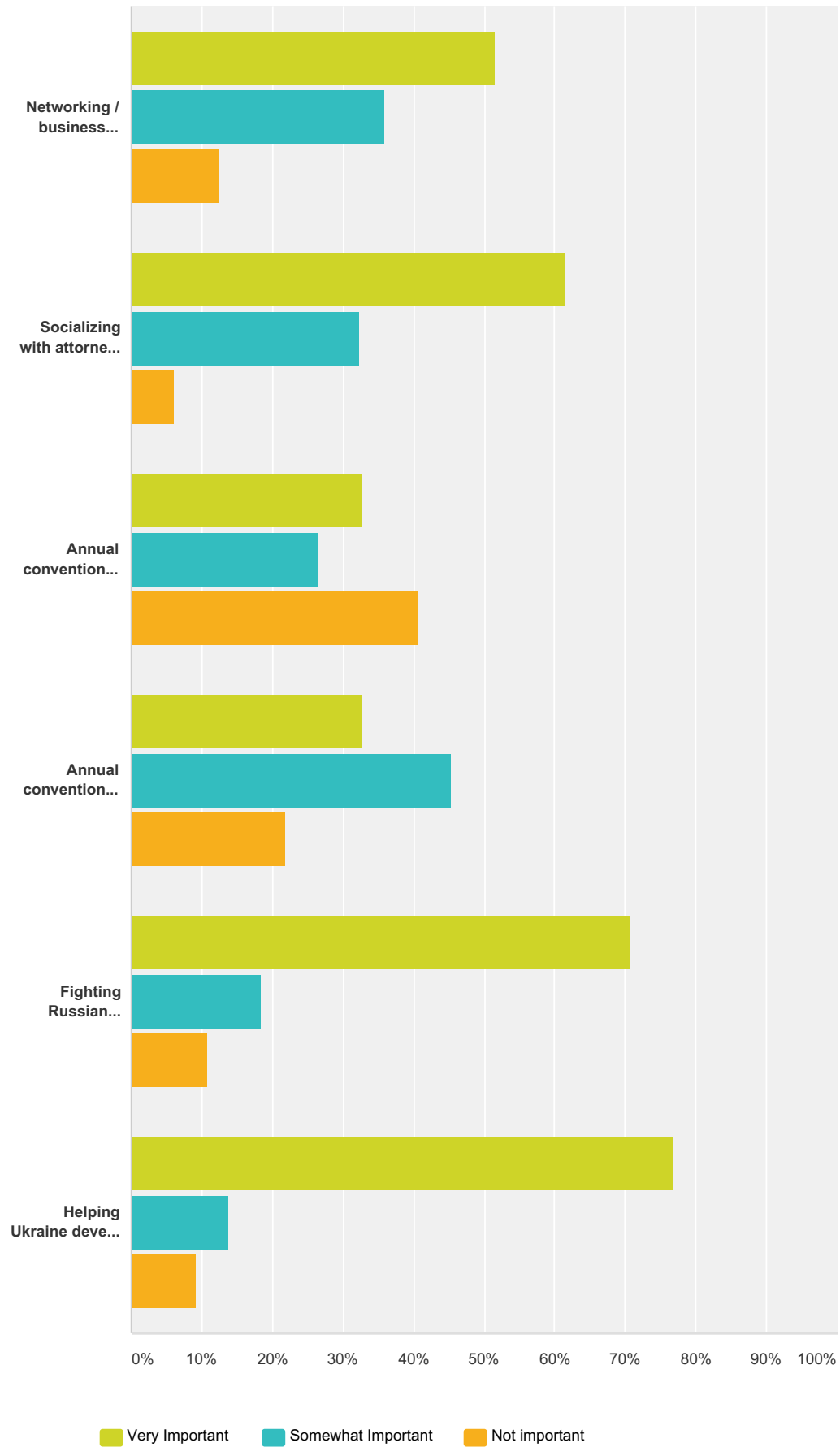

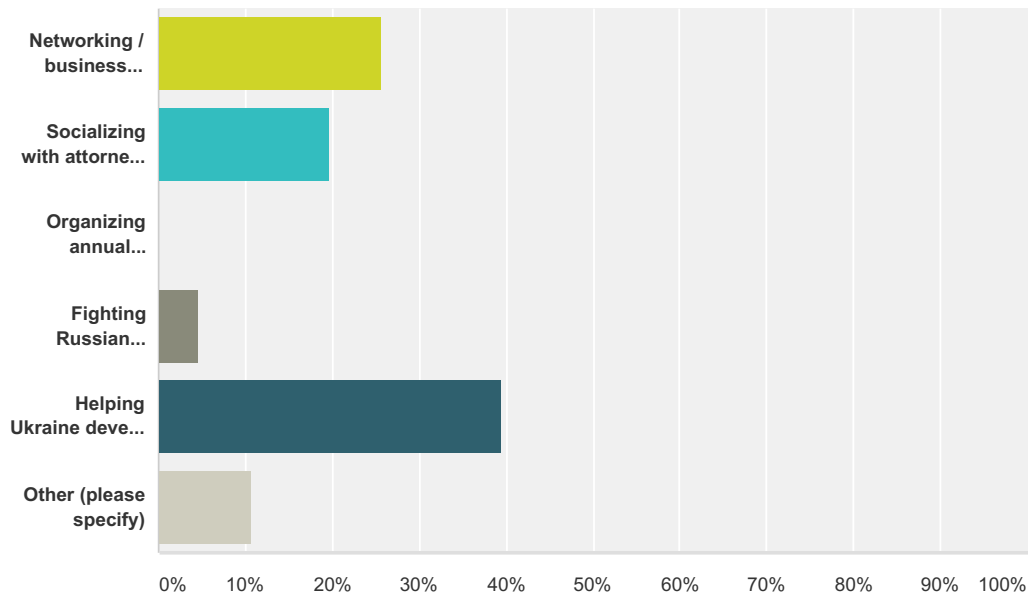

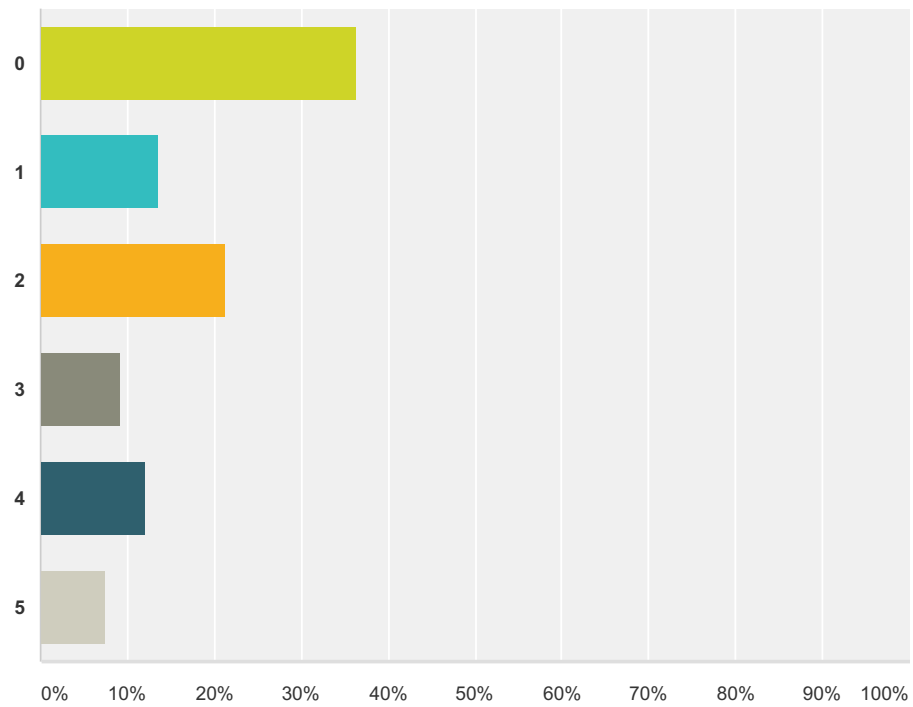

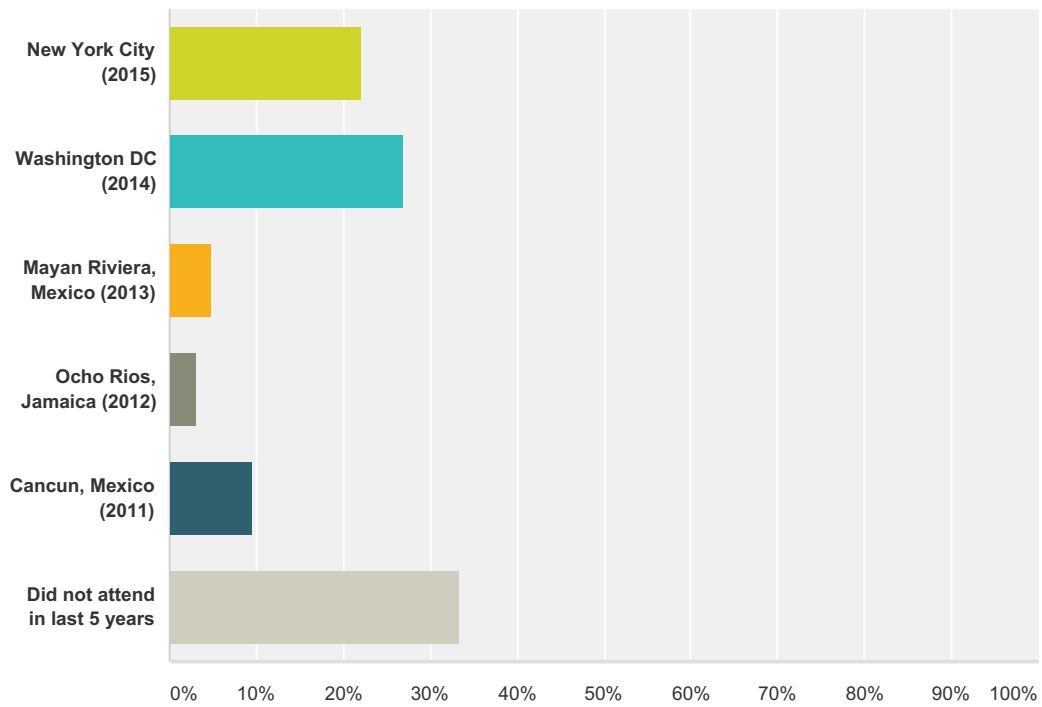

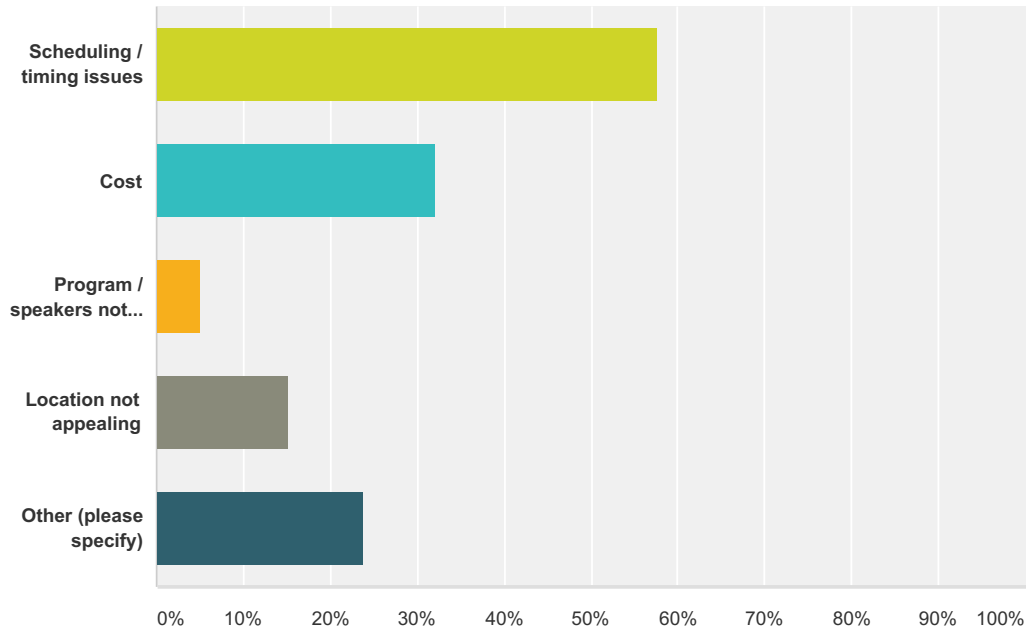

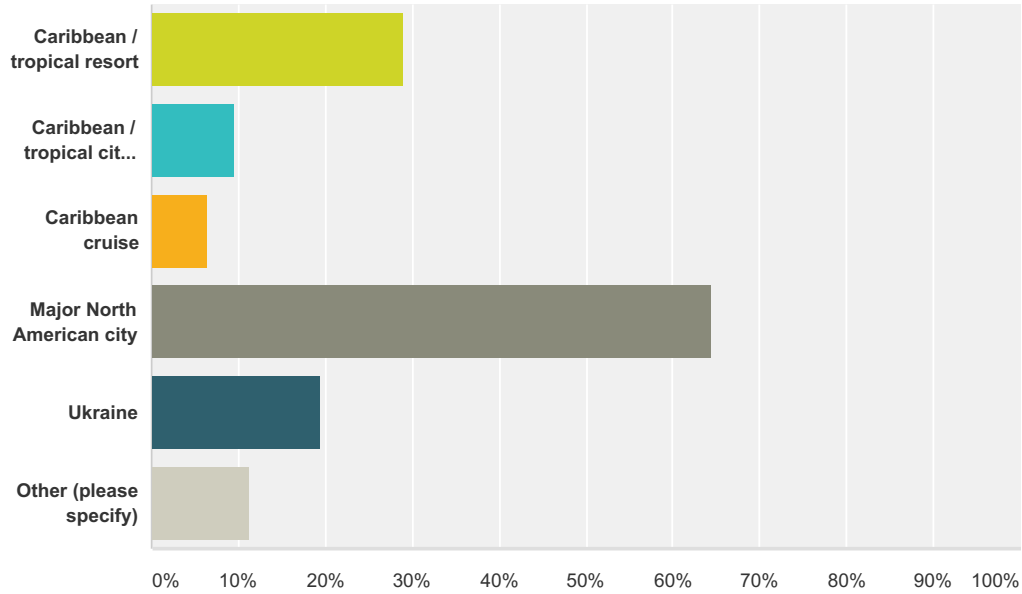

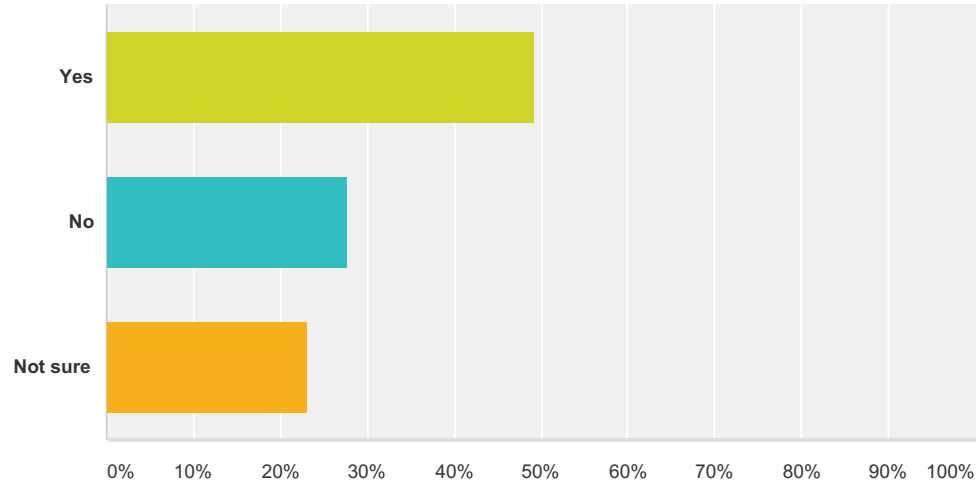

### Q9 If the 2016 UABA convention were held in a Caribbean or tropical resort location, are you likely to consider attending?

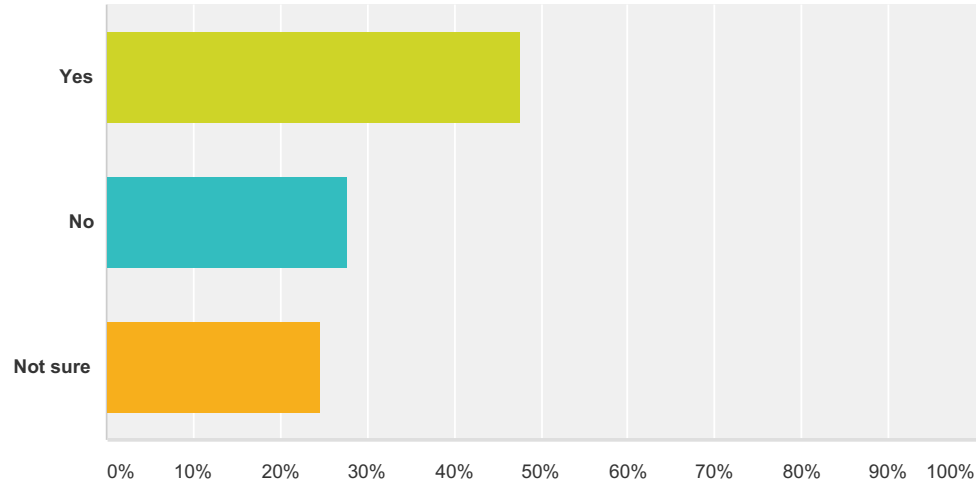

**Q10 If the 2016 UABA convention were held in a Caribbean or tropical city or urban area, are you likely to consider attending?**

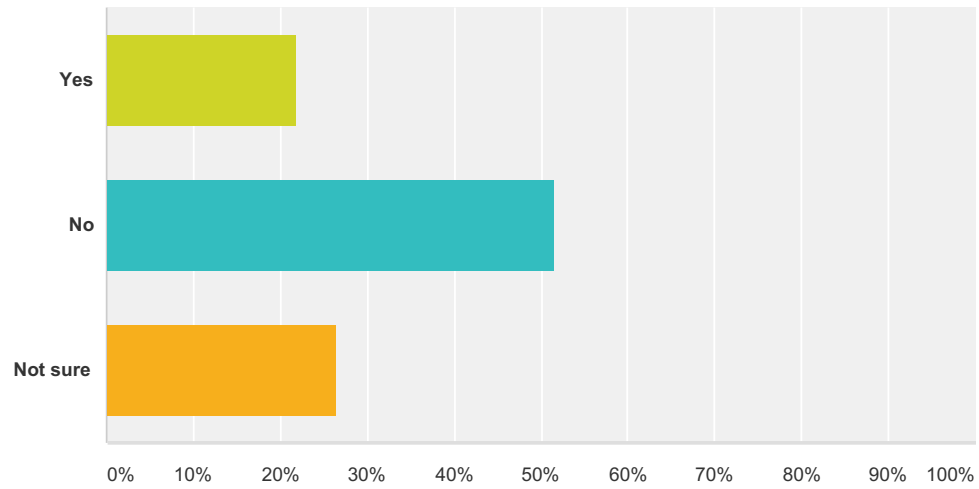

### Q11 If the 2016 UABA convention were held during a Caribbean cruise, are you likely to consider attending?

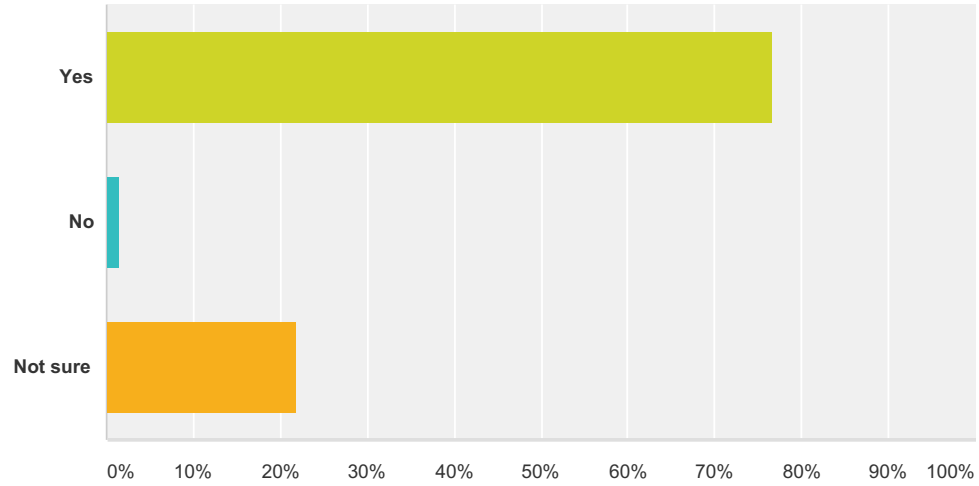

**Q12 If the 2016 UABA convention were held in a major North American city, are you likely to consider attending?**

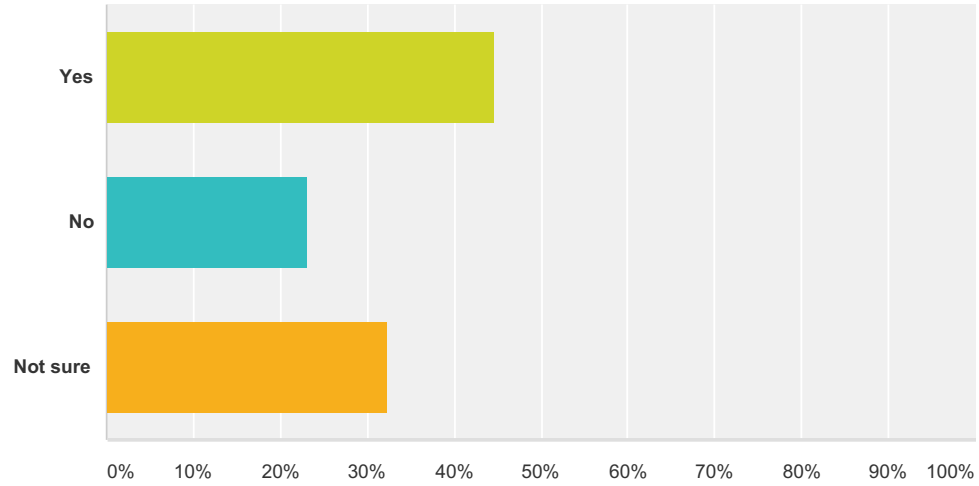

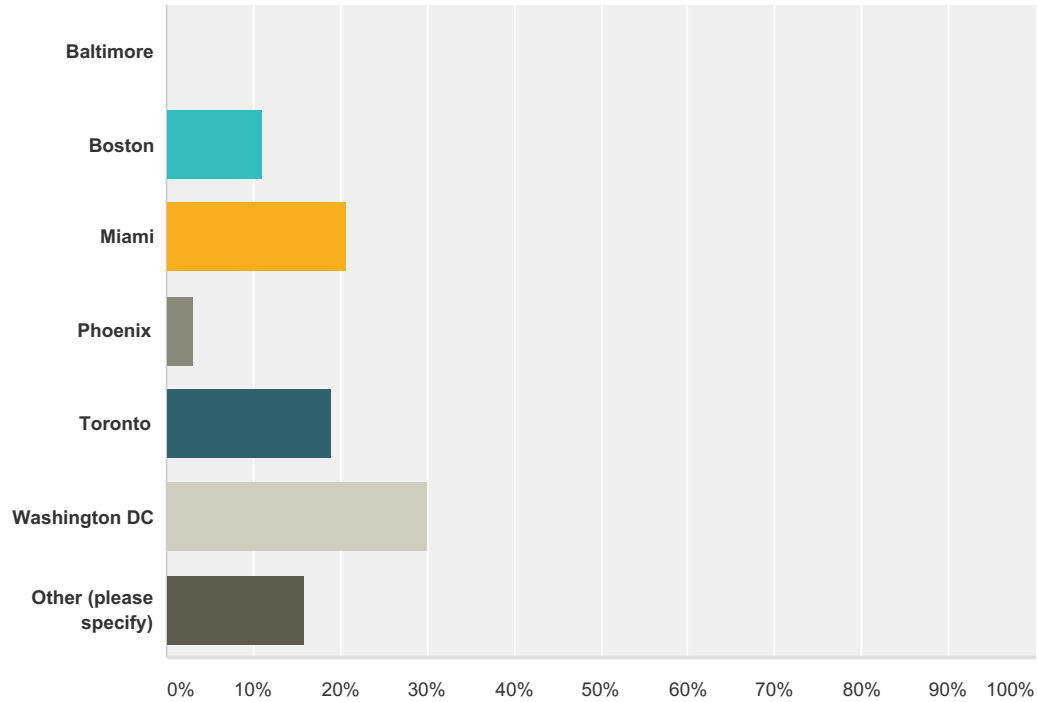

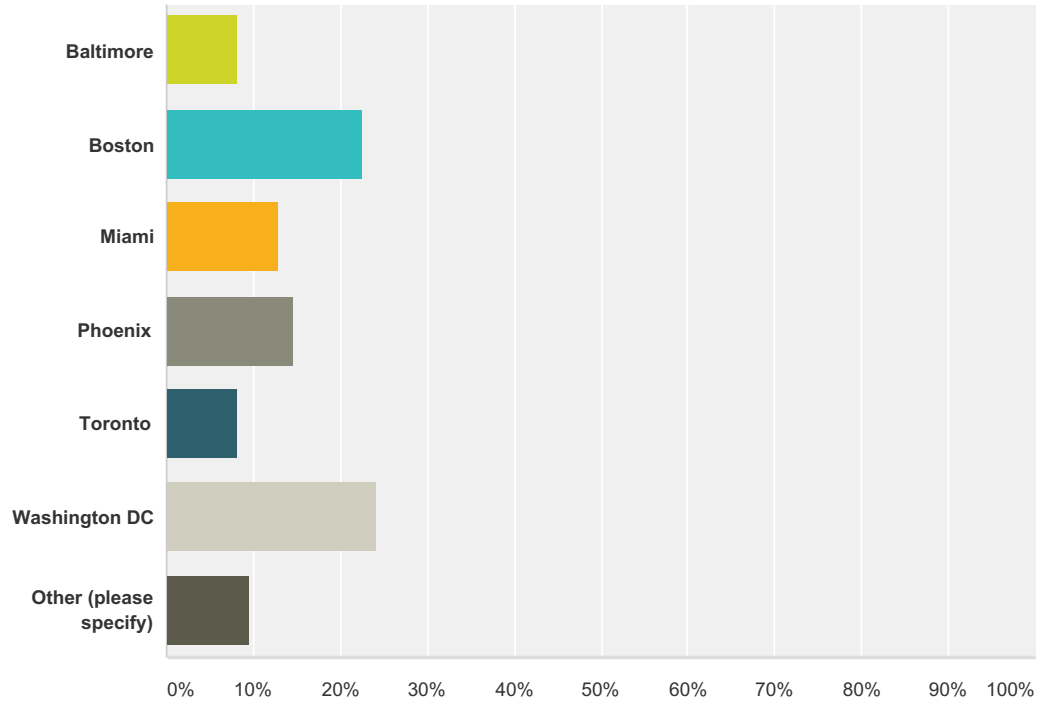
